# WHAT IS THE CAUSE FOR THE DEATH OF COVID-19 PATIENTS? WAYS TO PREVENT UNEXPECTED DEATHS!

Common symptoms of corona infection include fever, cough, fatigue, shortness of breath and loss of sense of smell. Pneumonia and severe shortness of breath can occur as the disease progresses. There is no antiviral treatment for this. Symptom reduction and supportive therapy are the current practice in Allopathy medicine.

The prevention activities from Corona includes, sanitisation of hands, closing mouth while sneezing and coughing, keeping distance from strangers, wearing face masks in public places, monitoring the persons afflicted with pandemic and self- quarantine.

Keeping social distancing and keeping isolated are the best ways for preventing the pandemic to be spread, than wearing Face mask.

There are several activities in the human body that are quite surprising. Like heart beat, hearing, seeing, pregnancy, sleeping, realising the taste and pain, the natural "blood clotting" is also quite surprising. If the blood is not clotted, even a simple injury would result in death.

Such an important aspect of "**Blood clotting**" is occurring as a chain reaction. The Flat Protein and Pospo Protein combines together and get converted into new Thromboplastin from blood oozing out from the blood vessel. It acts with Blood clotting factors and gets changed into Thrombokinase.

By that time, the protein called Prothrombin starts from liver and it reaches the affected blood vessel due to blood circulation. Having reached that place, it combines with Thrombokinase Calcium metal sand gets converted into Thrombin Enzyme. This reacts with Fibronogen in the blood. As a result, lenghthy Fibrine Fibres are created. This creates a netting. In this net, platelet, blood cells and Plasma are imprisoned. Then, this net shrinks and a blood clot is formed. Like blocking the water tap with a cloth, this blood clot is blocking the torn blood vessel and prevents the bleeding of blood.

Blood clot is like a double edged knife. Only when the blood oozes out from the body, the blood should clot. If the blood is clot during normal circulation in the body, the same would be danger to life. For example, if blood in the Coronary arterial tube which pumps blood to the heart is clot, the same would lead to Heart Attack. If this happens in the Arterial tube in the brain, that will lead to Paralytic attack.

Only since this blood clot which would seriously affect the Covid-19 patients, the death rate is continuously increasing at present.

It is noticed that in the blood samples of persons severely affected by Covid-19, the quantity of **D-Dimer** is found in excess. Normally the amount of blood clotting and the dimension of tumors are measured by the activity of D-Dimer. Accordingly, not only in blood, but also in any part of the body if blood clots are formed, the quantity of D-Dimer in the blood would get increased.

Hence, this indicates that in the COVID-19 affected patients, there is a formation of several blood clots.

For reducing blood clots and the damage to other organs, certain Allopathy Doctors prescribe more quantity of medicines to the patients which dilutes blood.

As these patients are already affected, CT Scan could not be taken on them. Till the cause for the formation of tumors are diagnosed and till the further test results are disclosed, the Allopathy Doctors use to prescribe these medicines which dilute the blood.

The deficiency in breathing found in the COVID-19 Patients is also found normally in the patients with lungs diseases and persons affected with breathing defects. The blood clot and the tumors formed in the blood vessels of these patients causes severe allergic conditions. Hence the chances of Heart Attack and Paralytic attack are more for these patients.

Safety drugs which are not having any side effect have to be invented successfully on a war footing measure. Only with that process, this dangerous circumstances and the death of these patients could be prevented.

Is this possible in Allopathy medicines? is not known to us. Even if it is possible, Injections for preventing blood clotting such as 'Heparin Injection' that are being administered in Allopathy causes dangerous side effects leading even to death.

Besides, the side effects of the medicines prescribed in Allopathy for preventing blood clotting and for diluting the blood and the medicines that are being prescribed for Covid-19 patients have to be scrutinised fully.

It is also to be scrutinised carefully whether **Hydroxychloroquine** that is being prescribed to Covid-19 patients and the medicines that are being prescribed to Covid-19 patients would cause the danger of excessive blood clot.

Furthermore, RT PCR is being used worldwide to diagnose corona infection, immediately after RT-PCR (**Reverse Transcription Polymerase Chain Reaction**) Test which confirms the positivity of a Covid Patients, before prescribing Allopathy medicines to those patients, it has to be ascertained whether the quantity of **D-DIMER** of that patient is in control or in excess.

If the quantity of D-Dimer is excess, the danger of blood clotting and formation of tumor could be diagnosed in advance and the proper medicines could be prescribed. If before administering allopathy medicines, the quantity of D-Dimer is normal, within 5 or 10 days after the administration of such drug, again it has to be tested that the quantity of D-Dimer in blood is normal. By adopting this procedure, it could be notice minutely whether the quantity of D-Dimer increases due to Covid pandemic or the quantity of D-Dimer is increased due to the administration of drugs. This would reduce unexpected deaths, Heart attack and Paralytic attack due to Blood clot.
