## 12. FIR Contents

Today 08.10.2018 at 20.00 hrs received the complaint of Dr.T.Sengottaiyan, M.V.Sc., The Deputy Secretary to The Governor and Comptroller, Tamil Nadu, Raj Bhavan, Chennai. Which was addressed to the Commissioner of Police, Vepery and further sent to myself vide reference no. C.No.1062/Addl.Cop/L&O/S/HO/2018 of the office of the Additional Commissioner of Police, South (L&O), greater Chennai Police and Rc.No.167/DCT/CAMP/Addl.Cop/2018 of the Office of the Deputy Commissioner of Police, Triplicane District, Greater Chennai Police, the content of the complainant which run as follows: From, Dr.R.Sengottaiyan, M.V.Sc., The Deputy Secretary to Governor and Comptroller, Tamil Nadu Raj Bhavan, Chennai. To, The Commissioner of Police, Vepery, Chennai. Sir, Sub: Complaint un der Section 124 of Indian Penal Code against Nakkeeran Gopal and others. We wish to bring to your notice, alleging that, with an approval of Press and Registration of Books Act, 1867, thrice a week under the title"NAKKEERAN", a Tamil Magazine, is being published by Mr.Nakeeran Gopal on behalf of Nakeeran Publication, having office at No.105, Jani Jahankhan Road, chennai-14. As per the declaration, it is seen that the same is printed at Nakkeeran Printers and Binders, having office at the same address and the Editor is shown as Nakkeeran Gopal.

From the Statutory declaration printed in the Magazine, it is seen that the Editor-In-Charge of the said Magazine is shown as Kovi. Lenin, chief Deputy Editors are Aaraavayal, AaroorTamilnaadan, Era. Tha. Sakthivel Chief Special Reporters are Era. Illiyaselvan, Dhamodharan Prakash, Deputy Editors are C.N.Ramakrishnan, E.Pa. Parameshwaran, Assistant Editors are M. Senthilkumar, Ka. Subramanian, Principal Reporters are Jeevathangavel, Paramasivan, Chief Reporters are Sakthivel, S.P. Sekar, J.D.R. Manosoundher, Reporters are Raja, Bagatsingh, Arulkumar, Manikandan, Selvakumar, Aravind, Jeevabharathy, Arunpandiyan, Shahul, Coordinator is A. Ponnusamy, Managing Director is R. Gurusamy, Chief Production Manager is R. Sundar, General Manager is S. Sureshkumar, Administrative Manager is C.Francis, Distribution Manager is K.Malaikannan, Distribution Assistant Manager is Sathiyaseelan and Distributors are shown as K.Balasubramanian, Lawrence and Aravind.

The Press and Registration of Books Act is intended to regulate Printing Press and Newspapers for preservation of copies of books and newspapers printed in India for regulation of the same. It is seen from the Article published on Volume 31 of Issue No.1, 2018 April 20-22, of Nakkeeran Tamil Magazine that the wrapper page mentions with the caption "Breaking News" with further qualifying statements that "nakkeeran had belled the cat and Governor caught in the trap" and there was danger for Nirmala at Jail. Article starts at from the page with the photographs of His Excellency Hon'ble Governor of Tamil Nadu. The contents of the Article are published misusing the licence to permit publication, making statement in the nature of gesture, conveying that the persons behind the publication, who are aforementioned are preparing to use the same against His Excellency the Governor. That apart, the allegations in the Article are per sedefamatory. The contents of the Article are clearly an expression of intention of inducing or compelling His Excellency the Governor of the State of Tamil Nadu, to refrain from excercising his lawful powers as a Governor. Section 124 of the Indian Penal Code reads thus:

"Assaulting President, Governor, etc, with intent to compel or restrain the excercise of any lawful power.-Whoever, with the intention of inducing or compelling the [President] of India, or the [Governor [\*\*\*]] of any [State], [\*\*\*] [\*\*\*] to excercise or refrain from excercising in any manner any of the lawful powers of such [President] or [Governor [\*\*\*]], assault or wrongfully restrain, or attempts wrongfully to restrain, or overawes, by means of criminal force or the show of criminal force, or attempts so to overawe such [President or [Governor [\*\*\*]], shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine."

Not stopping with the same, in Volume 31, Issue No.2, 2018 April 23-25, of the said Magazine under the heading "to protect Purohith, IPS Official was changed' and further caption 'University Mysterious Bungalow' important personalilites captured on CCCTV and a statement as thought made by Nirmala Devi under the quotes "as though the Governor does not know me". "Nirmala not shaken by Governor" was poublished. In the said Article, allegations and statements have been made, which are clearly and expression of intention to compel His Excellency the Governor to refrain from exercising his powers. The contents of the Article are per sedefamatory and malicious. Thereafter, in Volume 31, Issue No.48, 2018 September, 26-28, under the caption "Four times I have met the Governor". "Danger awaits Nirmala Devi, who make shocking revelation". In the said Magazine at Page. No,6, the photograph of Nirmala, His Excellency the Governor and Secretary to Governor Mr. Rajagopal, I.A.S., have been published. The contents of the said Article cleraly to convey the intention and amounts to compelling of His Excellency the Governor to refrain from exercising his lawful powers as the Head of the State. The contents of the Article attempt to overawe. Apart from being defamatory, the article in Volume 31, Issue No.1 aforementioned has been written by the Chief Editor Mr. Nakkeeran Gopal himslef and his signature is found. The Article in Volume 31, Issue No.2, has been written by Mr.C.N. Ramakrishnan and that the front page picture was taken by Mr. Ramkumar is printed therein. The Article in Volume 31, Issue No.48, aforementioned, has been written by Dhamodharan Prakash and C.N. Ramakrishnan and the pictures are shown to have been taken by Stalin.

Under the provisions of Press and Registration of Books Act, when declaration at the time fo avilaing permission is given, it is expressly admitted that, nothing would be done against the State. As Editor in Chief, Nakkeeran Gopal, Kovi, Lenin, Chief Deputy Editors viz. Aaraavayal, AaroorTamilnaadan, Era. Tha. Sakthivel, Chief Special Reporters viz. Era. Illaiyaselvan, Dhamodharan Prakash, Deputy Editos are C.N.Ramakrishnan, E.Pa. Parameshwaran, Assistant Editors viz. M. Senthilkumar, Ka. Subramanian, Principal Report ers are Jeevathangavel, Paramasivan, Chief Reporters viz. Sakthivel, S.P. Sekar, J.D.R. Manosounther, Reporters viz. Raja, Bagatsingh, Arulkumar, Manikandan, Selvakumar, Aravind, Jeevabharathy, Arunpandiyan, Shahul, Coordinator A.Ponnusamy, Managing Director R.Gurusamy, Chief Producton Manager R. Sundar, Generalk Manager S.Sureshkumar, Adminstrative manager C. Francis, Distribution Manager K. Malaikannan, Distribution Assistant Manager Sathiyaseelan and Distributors viz as K. Balasubramanian, Lawrence and Aravind have all conspired, connived and acted in convert, got the Articles written, which are clearly expressing their intention of inducing and compelling His Excellency the Governor of State of Tamil Nadu, to refrain from excercising his lawful powers. Under the provisions of Constitution of India as the Governor of the State His Excellency could exercise executive powers of the State under Article 162 vests with the Governor. The aforementioned persons cannot claim, any immunity under Article 19(1)(a) of the Constitution of India as the freedom of speech and expressing is subject of restrictions contained under Art. 19(2) of the Constitution of India.

Thus, I seek your goodself to register a complaint under Section 124 of the Indian Penal Code against aforementioned persons, take congnizance and bring to book the culprits. As per the above petition a case was registered U/s 124 IPC., and myself tookup the investigation of the case.

13. Action Taken: Since the above report reveals Commission of Offence(s) u/s as mentioned in item No.2, registered case and took up the investigation.
