Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamilnadu 2. Thiru K.N.Manivannan (brother of Thiru K.N.Nehru) 3. Thiru N.Ravichandran (brother of Thiru K.N.Nehru), 4. Thiru Kavi Prasad (close associate of Thiru K.N.Nehru) 5. Thiru D.Ramesh and 6. Thiru D.Prabhu, being directors and managers of M/s TVH Group of Companies, Chennai along with unknown officials of Municipal Administration, Urban and Water Supply Departments, unknown private individuals/contractors/companies and

The report further alleged in brief that they have cheated the Government of Tamil Nadu and public at large in awarding government contracts/works in the above period and

thereby obtained wrongful gain of Rs.1020.00 Crore by Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamil Nadu through Thiru K.N.Manivannan, Thiru N.Ravichandran, Thiru Kavi Prasad, Thiru D.Ramesh, Thiru D.Prabhu of M/s TVH Group of Companies, unknown public servants and private individuals.

2. On the basis of the permission granted by the Government vide Letter No.AC/968-1/2025 Public (SC) Department, Dated 10.12.2025, a Detailed Enquiry was conducted after registration vide DE.125/2025/PUB/HQ dated 12.12.2025.

3. The Detailed Enquiry conducted on the basis of the above report primarily reveals that 1. Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamilnadu 2. Thiru K.N.Manivannan (brother of Thiru K.N.Nehru) 3. Thiru N.Ravichandran (brother of Thiru K.N.Nehru), 4. Thiru Kavi Prasad (close associate of Thiru K.N.Nehru) 5. Thiru D.Ramesh and 6. Thiru D.Prabhu, being directors and managers of M/s TVH Group of Companies, Chennai 7. Tmt.Sasipriya, the then Town Planning Officer, Coimbatore, 8. Thiru G.Balachandran, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region, 9. Thiru.G.Murugesan, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region, 10. Thiru S.Sudarshanam, the then MLA, Madhavaram Constituency, 11.Thiru.J.J.Ebenezer, the then MLA, R.K.Nagar Constituency, 12. Proprietor and office bearers of M/s C.T.Constructions, Chennai, 13. Thiru K.Sathish Kumar, Contractor, Chennai along with unknown officials of Municipal Administration, Urban and Water Supply Departments, unknown private individuals/contractors/companies and others entered into criminal conspiracy at Chennai and other places of Tamil Nadu to cheat the Government of Tamil Nadu by obtaining illegal gratification through public servants and private individuals in the guise of "party fund" and to loot the public exchequer in the matters related to awarding of contracts in Municipal Administration,

Urban and Water Supply departments during the period from 2021 to 2025 by creating false documents/records with the active participation of senior officials of the said departments.

4. A-1 Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamil Nadu was well aware that he should not indulge in corrupt activities while exercising his authority in official dealings in view of the oath taken at the time of assumption of charge as a Minister in the cabinet of Government of Tamil Nadu. He is further aware that public servants should not engage private individuals to access the confidential information related to the works envisaged by the government in any manner. By the authority and basic duty of the Minister, he is abstained from aiding anyone in their official capacity to contravene the procedures and norms in awarding tenders since the same would affect the public exchequer. Likewise, A-10. Thiru S.Sudarshanam, the then MLA, Madhavaram Constituency and A-11.Thiru.J.J.Ebenezer, the then MLA, R.K.Nagar Constituency were also fully aware of the office of oath in exercising their duties. They were further aware about the duties and responsibilities casted upon them by the Constitution of India. More particularly, they have the knowledge that they should not recommend for awarding contracts of government work in any manner prejudicial to the interest of equality and justice.

5. Public servants of Municipal Administration, Urban and Water Supply departments of Government of Tamil Nadu namely A-7. Tmt.Sasipriya, the then Town Planning Officer, Coimbatore, A-8. Thiru G.Balachandran, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region, A-9. Thiru.G.Murugesan, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region were also aware that they should not indulge in collecting illegal gratification in the matters of awarding government works and execution of the works in any manner by engaging anyone. They were also known about the procedures followed in awarding tenders.

6. Knowing full well that public servants should not engage anyone to access with the public servants, in pursuance of the said criminal conspiracy, A-1 Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamil Nadu deliberately facilitated/allowed A-4 Thiru Kavi Prasad

(close associate of Thiru K.N.Nehru), the then Director of M/s TVH Group of Companies, Chennai to contact IAS officers of the departments of Municipal Administration, Urban and Water Supply for ascertaining the works to be done by the said departments well in advance so that they could prefix the contractors of their choice with the intention to collect illegal gratification in the name of party fund. As per such facilitation and close association with A-1 Thiru K.N.Nehru, being in close touch with senior IAS officers by way of arranging meetings with the minister, communications through whatsapp chats with contractors and public servants, A-4 Thiru Kavi Prasad has made some contractors as successful bidders in the tenders invited by the said departments after collecting illegal gratification at the rate of 7.5% to 10% of the contract value through public servants and private individuals. The acts of A-4 Thiru Kavi Prasad are evident through the pictures extracted from his mobile phone that the bidders were prefixed by them before opening of tenders in the said departments for the purpose of getting illegal gratification in the guise of party fund. In the same manner, the contractors have paid illegal gratifications to public servants including A-10. Thiru S.Sudarshanam, the then MLA, Madhavaram Constituency, A-11. Thiru.J.J.Ebenezer, the then MLA, R.K.Nagar Constituency.

7. The following pictures in phone chats read that A-4 Thiru Kavi Prasad had arranged appointment for senior IAS officer of CMWSSB with A-1 Thiru K.N.Nehru. A senior officer under the control of A-1 Thiru K.N.Nehru has expressed his intention to meet A-4 Thiru Kavi Prasad. One of the senior IAS officers shared the names of several IAS officers to A-4 Thiru Kavi Prasad, who has been getting details of progress made in government projects, details about disputes raised by IAS officer about a contractor, details of inspections, etc. This clearly shows the nexus between A-4 Thiru Kavi Prasad and A-1 Thiru K.N.Nehru, the then Minister and also his interference in functioning of MAWS department.

Further, the WhatsApp chat dated 06.09.2021 (Picture No.19), extracted from the mobile phone of Tr.Kaviprasad (A-4) shows that a contact saved as "S.Sudarshanam MLA" (Mobile No.9940016596) sends a photo to Kavi Prasad consisting details of various tenders. The photo of the chat extracted from the phone of Kavi Prasad is as follows:

The enquiry on above chat revealed that for the contract at Sl.No.14, last date for bid was 21.09.2021. Even before the last date of the bid, S.Sudarshanam, former MLA, Madhavaram Constituency is rounding the Sl.No.14 and stating the name of the contractor "C&T" in blue ink. The value of the contract amount was written in pencil as Rs.75 lakh. However as on 06.09.2021 (date of chat) even prior to the tender opening, the work had allegedly been pre-decided in favour of M/s.C&T Constructions, Chennai. As per the recommendation made by Thiru S.S.Sudarshanam, communicated to Tr.Kavi Prasad through Whatsapp on 06.09.2021 i.e. 22 days before the tender opening date 28.09.2021, and the work was subsequently awarded to the said contractor, supporting the allegation of manipulation of the tender process for the purpose of undue advantages.

9. In another WhatsApp chat dated 30.07.2024 (Picture - 49, 50) extracted from the mobile phone of Kaviprasad (A-4) (Mobile No.9840105252), shows that a contact saved as "MLA Ebenezer RK Nagar" (Mobile No.9444658757) which sends a photo

of his letter under the letter pad of Tr.J.J.Ebenezer, RK Nagar MLA, containing the details of various contracts and thereafter sends another photo of bribe calculation sheet to A-4 Thiru Kavi Prasad. The photo of the chat extracted from the phone of Kavi Prasad is as follows;

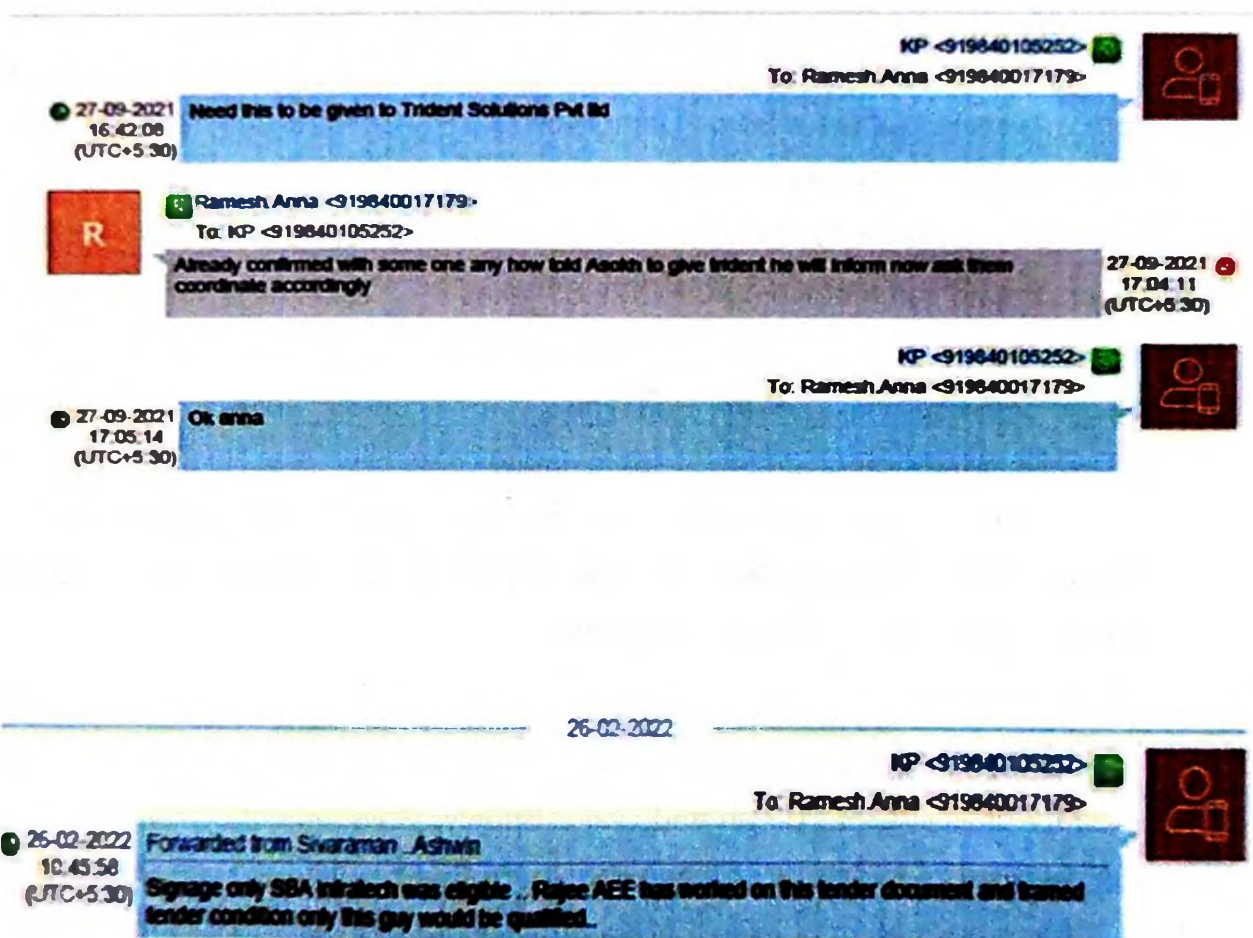
10. The enquiry on the above calculation revealed that the first column is related to package 2, 6 and 9 (Which were ticked in black ink at Sl.No.1, 3 & 4 of the letter given by the MLA). The second column provides the contract value at Rs.525.31 lakh. The bribe (Party Fund) was calculated at Rs.55.15 lakh (at the rate of approx. 10%).

It is further stated that Rs.15 lakh was already paid and Rs.35.15 lakh was balance bribe receivable. This is evident that contractors have paid illegal gratification at the rate of 10% to the value of the contract. The MLA informed Thiru Kavi Prasad that Rs.35.15 lakh was the balance illegal gratification supported by calculations.

11.The enquiry further revealed that E-tenders under two cover system were invited for the work of "Construction of SWD of size 1.20x1.20m at Ennore High Road (Lube Plant Road, railway track junction to culvert of culvert to Zone-1 existing drain) in Division-38, Zone-4, Package-2 vide S.W.D.C.No.B1/2630-2/2024 to the approximate value of work at Rs.256.16 lakhs". The E-tenders under two cover system was invited for the work of "Demolition and Re-Construction /New construction of Storm Water Drain at Sigirinthapalayam 11th and 12th Street and Kamarajar Nagar 11th Street in Division-47, Zone-4, Package-6 vide S.W.D.C.No.B1/2630-6/2024 to the approximate value of work at Rs.179.53 lakhs". The E-tenders under two cover system was invited for the work of "Construction of SWD of size 0.90x0.90m at K.K.Scheme Road (inside of the Port Trust) in Division-39, Zone-4, Package-9 vide S.W.D.C.No.B1/2630-9/2024 to the approximate value of work at Rs.89.62 lakhs". The work order for all the above three tenders were issued to A-13 Tr. K.Sathish Kumar on 06.09.2024 while it was pre-decided on 30.07.2024 itself i.e. 10 days prior to the date of opening of bid scheduled on 09.08.2024.

12. In pursuance of the said conspiracy, A-1 Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamil Nadu has willfully allowed A-2. Thiru K.N.Manivannan (brother of Thiru K.N.Nehru) A-3. Thiru N.Ravichandran (brother of Thiru K.N.Nehru) to coordinate with A-4. Thiru Kavi Prasad (close associate of Thiru K.N.Nehru) to collect the illegal gratifications obtained from the contractors and public servants through A-4. Thiru Kavi Prasad and spend the same for the projects entertained by M/s TVH Group of Companies. Further, A-1 Thiru K.N.Nehru allowed A-5 Thiru D.Ramesh and A-6. Thiru D.Prabhu to collect illegal gratifications from the public servants in the matter of tenders awarded to contractors of their choice in Thirupur and Coimbatore Regions. The associates of A-1 Thiru K.N.Nehru namely A-5 Thiru D.Ramesh and A-6. Thiru D.Prabhu, being associated with M/s TVH Group of Companies, have dishonestly collected illegal gratifications

from the contractors and public servants on behalf of A-1 and the same was evident through the following chats extracted from their mobile phones and statement of A-5 Thiru D.Ramesh recorded by Enforcement Directorate. At the instance of A-1 Thiru.K.N.Nehru, Tender conditions were formulated to accommodate the bidders of their choice through A-4 Thiru.Kavi prasad for getting illegal gratification. It is evident from the following pictures.



13. In the WhatsApp chat dated 26.11.2022 (Picture -112, 113), A-6. Thiru D.Prabhu informed A-5 Thiru D.Ramesh about illegal gratification of Rs.12.08 lakh received with a photo of the calculation sheet. He sends the calculation sheet and thereafter messages that Rs.12.08 lakh illegal gratification was received under Tirupur RE (RE-Regional Engineer) Account. The photo of the chat extracted from the phone of A-5 Thiru D.Ramesh is as follows.

14. As per the above calculation sheet, illegal gratification was collected in contracts related to construction of community toilets at various municipalities. The rate of bribes is 5% as stated in the last [right] column. The illegal gratification collected was Rs. 8 lakh from A-9. Thiru.G.Murugesan, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Udumalpet Municipality, Tirupur Region and Rs. 4.08 lakh from Pollachi Municipality totalling to Rs. 12.08 lakh. After sending this photo, A-6. Thiru D.Prabhu informs A-5 Thiru D.Ramesh that the amount of Rs. 12.08 lakh was collected from A-8. Thiru G.Balachandran, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region.

15. In furtherance of the said criminal conspiracy, tenders for the work of "Construction of Knowledge Centre at UKC Nagar Primary School Campus at Ward No.13" was awarded to the contractor M/s. SMV Project, Coimbatore at the instance of A-1 Thiru K.N.Nehru and his associates A-5 Thiru D.Ramesh and A-6. Thiru D.Prabhu in collusion with other contractors and the Regional Engineer of Udumalaipet Municipality, Tirupur District after obtaining Rs.8.00 Lakh as illegal gratification. Further, a work of "Construction of Community Toilet at KC Park back side under Clean India Project 2.O in Pollachi Municipality" was awarded to the contractor M/s. Sri KVR Constructions after obtaining Rs.4.08 lakh from the contractor.

16. In pursuance of the said criminal conspiracy, A-1 Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamilnadu has intentionally engaged private individuals and allowed A-5 Thiru D.Ramesh and A-6. Thiru D.Prabhu to collect illegal gratifications from the contractors for award of tenders in the municipalities of Dharapuram, Palladam, Velakovil, Gobichettipalayam, Sathyamangalam and Bhavani. In continuance of the association with A-1 Thiru K.N.Nehru, A-6. Thiru D.Prabhu, who has no official capacity to deal with the matters in the departments under the control of A-1 Thiru K.N.Nehru collected illegal gratifications at the rate of 10% on the value of the contract from the contractors who executed the works under various schemes. The following chat extracted from the mobile phone of A-6. Thiru D.Prabhu indicates the nexus between the public servants and private persons as well as contractors.

17. In the chat dated 25-12-2021 (Picture – 84) TPRABHU@A [for mobile number 82489 82781], has sent the details about illegal gratifications received from various contracts/ tenders to A-5 Thiru D.Ramesh as follows:

18. It further revealed that the details of contracts/tenders in various municipalities and the illegal gratification collected in the name of commission/party fund at the rate of 10% has been shown in last column of the above table, which was extracted from their mobile phones. The illegal gratification collected was Rs.155.79 lakh. The accounts have been prepared on 25-12-2021 with the heading "Tirupur Region". After sending this photo, A-6. Thiru D.Prabhu sends a message "Anna Tirupur RE-155.79 received" meaning thereby Rs. 155.79 lakhs have been collected from the then Tirupur Regional Engineer A-9 Thiru G.Murugesan. On 27-12-2021 (Picture – 85), A-5 Thiru D Ramesh, asks A-6. Thiru D.Prabhu as to what was the total balance. A-6. Thiru D.Prabhu responds that total balance with him was Rs.308 lakhs.

19. In the chat dated 07-07-2021(Picture – 89), A-6. Thiru D.Prabhu intimates A-5 Thiru D.Ramesh that Rs. 20.90 lakh is received from CBE TPO Sasipriya(A-7) with Reference of KNM [KNM refers to K.N. Manivannan). At 19.23 hrs on the same day, A-6. Thiru D.Prabhu intimates A-5 Thiru D.Ramesh that Rs.50 lakhs is received without further details.

20. This was admitted by A-5 Thiru D.Ramesh during the examination of Enforcement Directorate by stating *"TPO- Town Panchayat Office, KNM- K. N. Manivannan, Mrs. Sasipriya is an officer in TPO, Rs. 20.90 Lakhs was received & Rs. 50 Lakhs was received on 07.07.2021 by Mr. D. Prabhu for some contracting work"*

21. Detailed enquiry further revealed that Picture No.241 recovered from the mobile phone of A-2 Thiru K.N.Manivannan established the receipt of illegal gratification on awarding tenders by violating the procedures and disallowing the prospective bidders to participate in the government tenders.

22. In pursuance of the said criminal conspiracy, A-2 Thiru K.N.Manivannan has received illegal gratification in the government contracts at the instance of A-1 Thiru K.N.Nehru. It is evident through the images extracted from the media gallery of the phone of A-2 Thiru K.N.Manivannan, brother of A-1 Thiru K.N.Nehru and the same contains calculation of illegal gratification received from various persons as given below and the picture depicted.

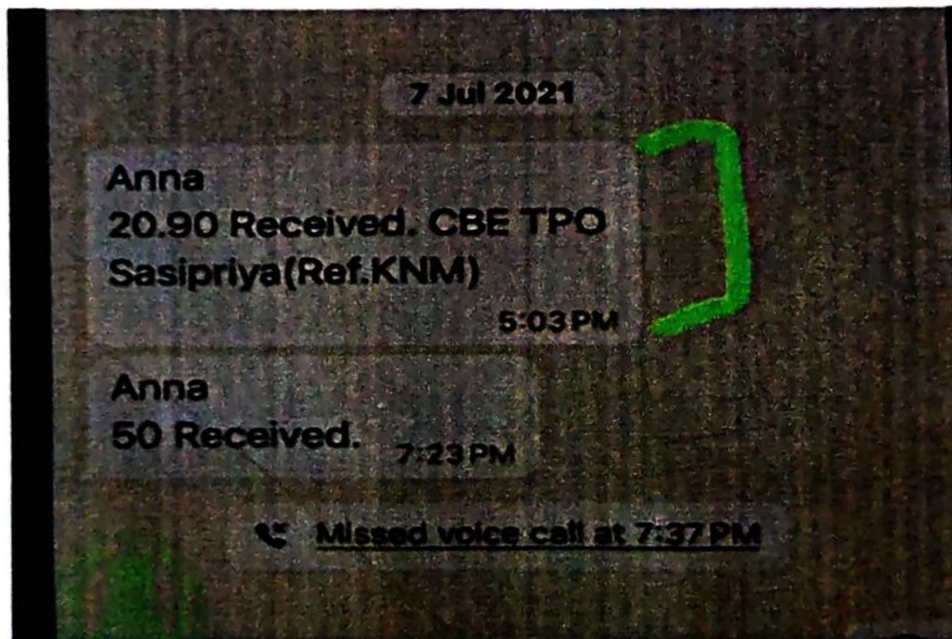

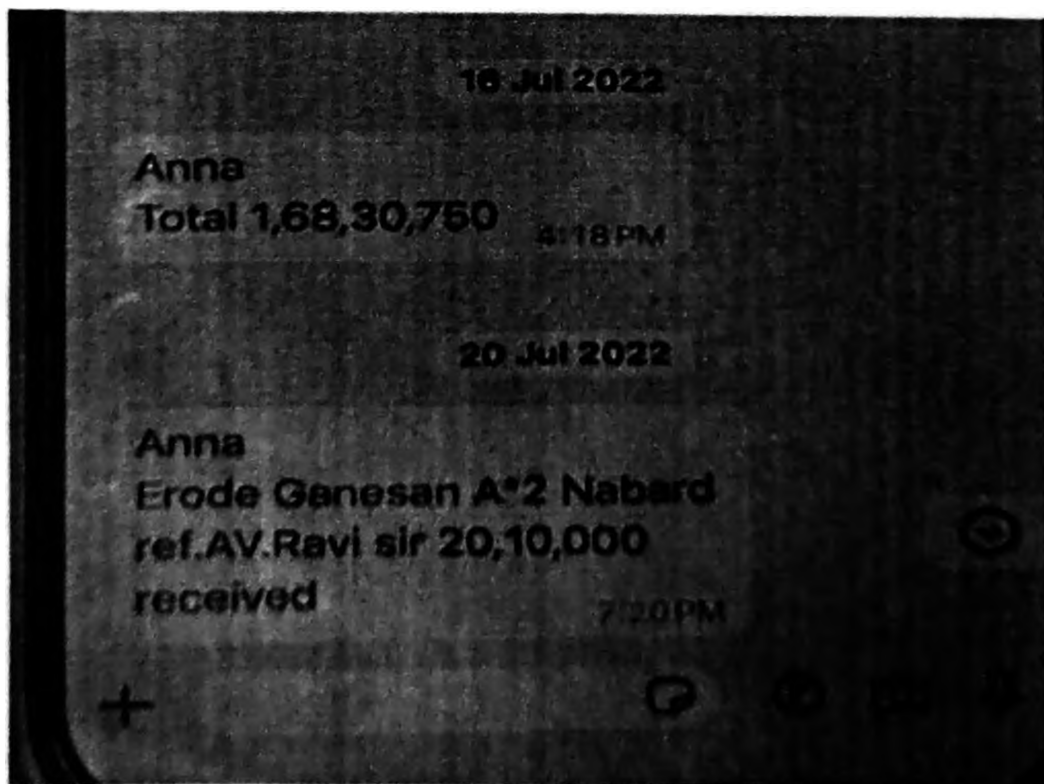
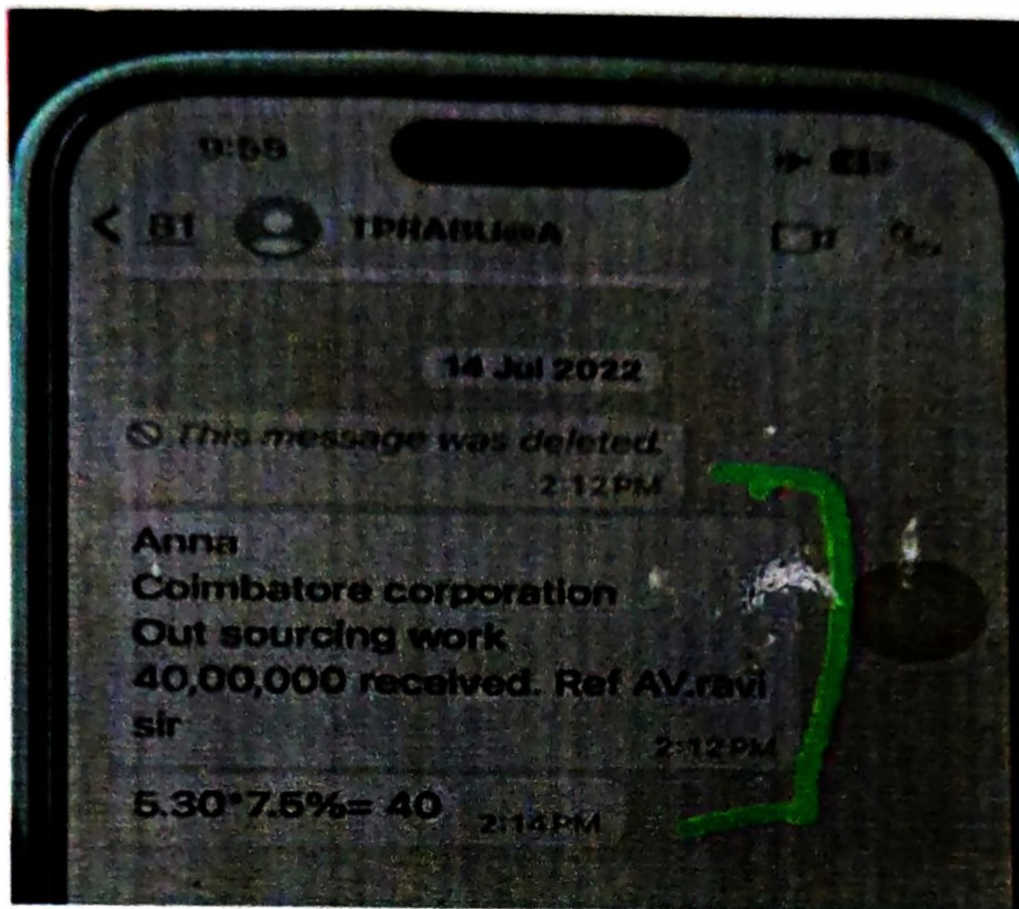
23. The above image corroborates with the illegal gratification collected by A-5 Thiru D.Ramesh, A-6. Thiru D.Prabhu and others. The entries stated therein match with the accounts given by A-6. Thiru Prabhu to A-5 Thiru D.Ramesh in his chats dated 20.06.2021 (Picture-146), A-6. Thiru D.Prabhu intimates A-5 Thiru D.Ramesh (addressing as Anna) that 26 lakh was received. The same amount with the same date is reflected in this image (Picture – 241) extracted from the phone of A-2 Thiru K.N.Manivannan, who has no role in interfering with official contractors and government works.

- i. The left side of the table describe the sources from whom the amounts were received, while the right side of the table indicate the persons to whom the amounts were handed over. The entries show that an amount of Rs.26.00 lakhs was received from A-7 Tmt.Sasipriya and that the said amount was handed over to A-2 Thiru K.N.Manivannan by A-5 Thiru D.Ramesh / A-6. Thiru D.Prabhu on 21.06.2021.
- ii. It further reflects a total bribe collection of Rs.1,198.20 lakhs from various persons and disbursal of Rs.1,166.90 lakhs to various persons, including A-2 Thiru K.N.Manivannan. As per the calculations contained in the said image, the amounts received through A-5 Thiru D.Ramesh mostly given to A-2 Thiru K.N.Manivannan, brother of A-1 Thiru K.N.Nehru, Minister for Municipal Administration, Urban and Water Supply (MAWS).
- iii. Further, a photograph of the chat conversation extracted from the mobile phone of A-5 Thiru D.Ramesh dated 09.08.2021, reveals that A-6. Thiru D.Prabhu informed A-5 Thiru D.Ramesh that he had received Rs.27.25 lakhs from A-7 Tmt.Sasipriya, the then Town Planning Officer, Coimbatore. A-5 Thiru D.Ramesh replied "Done" within eight seconds of receiving the said message.
- iv. Similarly, a photograph of the chat conversation extracted from the mobile phone of A-5 Thiru D.Ramesh dated 06.09.2021, reveals that A-6. Thiru D.Prabhu informed A-5 Thiru D.Ramesh that he had received Rs.27.30 lakhs from A-7 Tmt.Sasipriya, the then Town Planning Officer, Coimbatore. Thereafter, A-6. Thiru D.Prabhu intimated that the total amount of

Rs.2,10,15,000/- (Rupees Two Crores Ten Lakhs and Fifteen Thousand only) was received.

- v. A-7 Tmt.Sasipriya, while working as Town Planning Officer at Coimbatore and other places during the relevant period in 2021, had received illegal gratification from contractors and handed over the same to A-2 Thiru Manivannan, brother of A-1 through A-6. Thiru D.Prabhu and A-5 Thiru D.Ramesh. These facts were admitted by A-5 Thiru D.Ramesh during the interrogation by the Enforcement Directorate. These illegal transactions were recorded as pictures in the mobile phone of associates of A- 1 Thiru. K.N.Nehru and the same are depicted below.







24. It is further revealed from the chats in various dates that illegal gratifications were received in awarding government contracts by private individuals at the instance of A-1 Thiru K.N.Nehru. Specifically, a chat dated 09.02.2022 between A-6. Thiru D.Prabhu and A-5 Thiru D.Ramesh shows the illegal gratification of Rs.1.00 crore was collected from M/s.V.R Water Infra, Avinashi by A-6. Thiru D.Prabhu on the direction of A-3 Thiru K.N.Ravichandran. A chat dated 25.03.2022 reveals Rs.2.77 crores was received as illegal gratification from M/s V.R Water Infra, Perundurai. Further, a chat dated 28.02.2022 reveals that illegal gratification of Rs.5 Crore was received from V.R Water Infra, Velumani of Perundurai; Chat dated 20.01.2023 shows that illegal gratification of Rs.2.00 Crore received from V.R Water Infra, Velumani; Chat dated 19.04.2023 shows that illegal gratification of Rs.400 lakh received from V.R Water Infra, Velumani; Chat dated 02.03.2022 shows that illegal gratification of Rs.50 lakhs – reference from Coimbatore EE madam Avinashi Ravi sir; Chat dated 18.03.2022 shows that illegal gratification of Rs.52.66 Lakhs from DMK Erode North District Secretary and Rs.30 Lakhs from Nambiyur Varasanthai Mr.Sambanthamoorthy JE (Junior Engineer).

25. The above material and information reveals that 1. Thiru K.N.Nehru, the then Minister for Municipal Administration, Urban and Water Supply, Government of Tamilnadu 2. Thiru K.N.Manivannan (brother of Thiru K.N.Nehru) 3. Thiru N.Ravichandran (brother of Thiru K.N.Nehru), 4. Thiru Kavi Prasad (close associate of Thiru K.N.Nehru) 5. Thiru D.Ramesh and 6. Thiru D.Prabhu, being directors and managers of M/s TVH Group of Companies, Chennai 7. Tmt.Sasipriya, the then Town Planning Officer, Coimbatore, 8. Thiru G.Balachandran, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region, 9. Thiru.G.Murugesan, the then Regional Engineer, Office of the Regional Director of Municipal Administration, Tirupur Region, 10. Thiru S.Sudarshanam, the then MLA, Madhavaram Constituency, 11.Thiru.J.J.Ebenezer, the then MLA, R.K.Nagar Constituency, 12. Proprietor and office bearers of M/s C.T.Constructions, Chennai,

13. Thiru K.Sathish Kumar, Contractor, Chennai along with unknown officials of Municipal Administration, Urban and Water Supply Departments, unknown private individuals/contractors/companies and others have entered into criminal conspiracy in a organized manner and indulged in manipulation of government contracts/tenders under the ministry controlled by A-1 Thiru K.N.Nehru for illegal gratification received in the name of "Party Fund" at the rate of 7.5% to 10% of the contract value from pre-decided bidders identified even before the opening of bids and deliberately indulged in corrupt activities, which are illegal and not permitted in normal course of business.

26. The above information based on the detailed enquiry prima facie discloses the offences of criminal conspiracy, criminal breach of trust, criminal misconduct and cheating punishable u/s.120-B, 406, 409, 420 IPC and u/s.61 (2), 316 (2), 316 (5), 318 (4) BNS and 7, 7A, 8, 9, 12, 13 (2) r/w.13 (1) (a) of Prevention of Corruption Act, 1988 as amended in the Prevention of Corruption Act, 2018 against A1-A13 along with unknown officials of Municipal Administration, Urban and Water Supply Departments, unknown private individuals/contractors/companies and others.

27. Therefore, this FIR is registered after obtaining prior permission of the competent authority u/s.17A of Prevention of Corruption Act, 1988 as amended in 2018. This day 04th September at 16.30 Hrs., I am registering a case in V&AC Headquarters Crime No.7/2026 u/s.120-B, 406, 409, 420 IPC and u/s.61 (2), 316 (2), 316 (5), 318 (4) BNS and 7, 7A, 8, 9, 12, 13 (2) r/w.13 (1) (a) of Prevention of Corruption Act, 1988 as amended in the Prevention of Corruption Act, 2018 against the marginally noted accused and taken up investigation. The FIR is submitted before the Hon'ble Principal Judge, City Civil and Sessions Court, Chennai along with the report dt.03.12.2025 containing 1 to 258 pages of Enforcement Directorate. The copies of FIR are forwarded to officers concerned.
